What is a doctoral degree?

- Requires the ability to contribute to a field through new data, solutions, theories, or analyses.
- The gate to the academic job.

- Develops advanced analytical and research skills.
- Opens up career opportunities in both academia and industry.
- Provides a high level of respect and recognition in your field.
- Allows traveling and networking at the global scale.

The cons

- Requires a significant time commitment.
- The academic job market is highly competitive.
- The process can be mentally and emotionally demanding.
- The publish or perish rule is becoming fierce.


What does a PhD student do?

- · Hangs with an academic supervisor who is recognized as a field's expert.
- Reads literature. A lot of literature.
- Tries to come up with interesting, novel, original research questions.
- Collects data.
- Learns theory(ies) and method(s).
- Writes things, but most of these things are flushed.
- Attends group meetings.
- Goes to conferences, workshops, summer schools, etc. in cool places (fully funded).
- Creates a network of people that share a common interest for a topic.
- · Tries to publish: fails miserably or celebrates avidly.
- Builds a REAL knowledge and a REAL expertise
- Has work, intellectual and life freedom.
- Has fun. A lot of fun.

Some innovative PhD positions available

- a minimum of 6 months abroad is not mandatory but strongly recommended (for this period the scholarship is incremented 50%)

Application procedure

- form available from the UNIBG web page
- application window early June early July
- interview 29 July 2 August



Structure

First year

Refining the topic, coming up with a research question, attending classes, choosing an advisor, starting the journey.

Second year

Start data collection and moving abroad for a research visit. Start writing the thesis but also articles. For innovative PhD programs staying at least 6 months in the firm that co-funds the scholarship. Attending conferences and start taking part to the academic debate in the area.

Third year

Finish the experience abroad. Developing the PhD thesis. Graduation.

Possibilities: Cotutelle with another PhD program abroad (with the opportunity of a double degree).
